5. Description of data	If a shareholder registers for the meeting over the Internet, the data collection is technically accomplished by Euroclear Finland Ltd. The connection from the user's browser to the server of Euroclear Finland Ltd is SSL-encrypted. The following information can be collected through this service: name, personal identity number, address, telephone, email address, book-entry account number, numbers of shares and votes.  A shareholder may also participate and exercise his/her rights at the meeting by way of proxy representation.  The book-entry account number is only used for identification in Euroclear Finland Ltd's system and it is not disclosed to the company.
6. Regular sources of data	When registering over the Internet, the data is entered by the registering party personally.
7. Regular disclosures of data or transfers of data outside the EU or EEA	No data is disclosed or transferred.
